## Acceptable Use of Technology Consent Form

Access to District technology is a privilege, not a right. The District's electronic network is part of the curriculum and is not a public forum for general use. Please carefully read the attached Acceptable Use of Technology policy. Violations may result in disciplinary action. Violations can include:

- Sending or displaying offensive pictures or graphics.
- Using obscene language.
- Harassing, insulting, threatening or abusing other network users.
- Violating copyright laws.
- Using another user's account and password.
- Damaging computers, personal or network files.
- Trespassing in another user's private files.
- Attempting to circumvent network security.
- Using the District account for commercial purposes or individual financial gain.

Unless otherwise instructed by school personnel, users shall not disclose, use, or disseminate personal identification information about themselves or others when using email, chat rooms, or other forms of direct electronic communication. Users are also cautioned not to disclose such information by other means to individuals contacted through the Internet without the permission of their parents/guardians. Personal information includes student's name, address, telephone number, Social Security number, or other individually identifiable information

By signing this agreement, I/we are signifying that I/we have read Acceptable Use Policy 361 and agree to abide by its terms. I/we understand that the computer network/computers are to be used solely for educational purposes and that there is no expectation of privacy with respect to the use of the same.

## USER Consent
