# Referendum: Who, What, Where, Why

On Monday, January 13, the West Salem school board decided to move forward with the process of holding a referendum to seek voter approval to proceed with two capital projects. The referendum ballot will offer two specific questions. The first question requests voter approval to borrow up to \$32 million for the purpose of constructing a new 4-8 middle/intermediate school. The second question seeks "one-time" permission to exceed the revenue limit by \$500,000 during the 2014-2015 school year for the purpose of providing security upgrades to our elementary school.

What will be built? A new school building designed to serve students in grades 4 through 8. The new building will consist of approximately 160,000 square feet of space including classrooms and shared spaces such as a cafeteria, library and gymnasium. In addition, the project will offer site development including a new access road connecting to Garland Street just east of the Lakeview Health Center. The project at the elementary school will include a more secure front entry and office area.

Where will the new building be located? The new 4-8 middle/intermediate school will be located on the property just to the north of our current soccer complex. The district purchased this land in 2007 as a future building site. Also note, the school district is currently completing an agreement with La Crosse County for the purchase of 25 additional acres to the east of the soccer complex. A portion of this new property will be used to create an access road to the proposed new school.



How will this impact my tax bill? The school district's current long-term debt payment is approximately \$2 million per year. This includes approximately \$1.3 million for the high school and the final \$0.7 million payment on the elementary school. Should the voters approve the first question and thereby direct the board to borrow an additional \$32 million for a new school, the new annual longterm debt payment will be approximately \$2.7 million. The expiration of the elementary school debt along with historically low interest rates results in a lower payment. The estimated long-term tax impact will be an increase of approximately \$.70 per thousand per year or \$70 for every \$100,000 worth of property.

In regards to approval of the second question providing one-time permission to exceed the revenue limit by \$500,000 for the purpose of security upgrades at our elementary school; the structure of our current debt payment schedule will allow the district to arrange its payments to accommodate this exemption without increasing the tax rate. In short, the final debt payment on our elementary school will be made in October, thereby creating a unique window to "fit in" a one-time exemption without impacting the tax levy.

Why is the district considering this now? The continued pressure of enrollments at our elementary school, the need for facility upgrades to our middle school, escalating construction costs, low interest rates and community input directing the board to "do it right" suggest now is the right time to move forward.

The elementary school is operating at or beyond capacity by serving nearly 800 children and their families on a daily basis. With more students expected to enroll in the future, there is little margin for error. The middle school is now more than 30 years old, and much like the high school prior to the 2001 remodeling project, will require a number of upgrades and expansions to remain a safe, healthy and productive facility moving forward.

The financial projections regarding future construction costs and interest rates indicate the cost of school district construction and remodeling projects will continue to rise. It appears waiting will cost more in the long run.

Finally, input offered at the community meetings held last summer suggested the school board seek the best long term solution by constructing a high quality, efficient, 21st century learning facility large enough to allow for future growth.

What will happen to the old middle school? The school board has been working with a number of local groups interested in repurposing the current middle school. In light of the school board's official decision to move forward with a referendum, the discussion and planning will become more formal.

What happens next? During the upcoming months there will be ample opportunities for each citizen to ask questions and gather information. Our district web site includes a separate page entitled "School Referendum Information." The page will be updated on a regular basis to offer current information and answers to commonly asked questions. The referendum process represents the purest form of school district governance. While nearly all district decisions are made by board members on behalf of the citizens they represent, referendums afford each citizen the opportunity for direct participation. To ensure this approach with respect to major financial matters, state law requires voter approval to enter into long-term debt and to exceed the annual revenue limit. This very definition of democracy requires each one of us to do our part - become informed and vote April 1, 2014!

# **QUESTION NUMBER II**

"Shall the School District of West Salem, La Crosse County, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$500,000 for the 2014-2015 school year, for non-recurring purposes consisting of security improvements at the Elementary School?"

### Important open enrollment dates

**February 3 – April 30, 2014 –** Parents must submit applications online or directly to the nonresident school district.

June 6, 2014 – Nonresident school districts must mail notices of approval or denial. If the application is approved, the school district must notify the parents of the specific school or program to which the student is assigned. If the application is denied, parents have 30 days to file an appeal.

**June 13, 2014** – Resident districts must notify applicants if the application is denied. If the application is denied, parents have 30 days to file an appeal.

June 27, 2014 – Parents of accepted applicants must notify the nonresident district if the student will attend the nonresident district in the 2014-15 school year. If the parent fails to make this notification, the nonresident district may refuse to allow the student to attend the district.




# **Congratulations Marina!**
