Welcome New Staff

From the back of the room, the new teacher surveyed the audience at the first inservice day. Not knowing one person in the room filled with over 2000 teachers was overwhelming, and feelings of loneliness and trepidation enveloped her. Due to her spouse having accepted a new position in a new city, the teacher had to leave the school district that she had attended for thirteen years as a student and taught in for over 20 years. To venture into a "new realm" alone was terrifying and yet exhilarating. Within a few short weeks the feelings of loneliness were gone and the warmth and support of professional colleagues and students brought comfort and confidence.

How well I remember this occasion. It was an event that I would repeat three more times during my career. This year as a district we welcome 17 new colleagues. With our mentoring process and warm caring staff members, I know that these individuals will feel as happy as I did about their new "family".

We are fortunate that we have been able to hire outstanding new staff members. As these new employees were interviewed the teams were excited about having such high-caliber individuals seek to join them in their labors. Let me introduce them to you.

Nicole Ellefson will assume the position of High School LMC Director. Nicole brings experiences as an elementary teacher, and LMC Director in the Westby School District. Nicole will also be a key member of the High School Senior Exit Project.

Very few student teachers are hired in the district where they did their student teaching. This year the pool of tech ed teacher applicants was very large and the candidate selected as the most qualified was Matthew Huenink, a recent graduate of Viterbo and fall 2008 West Salem student teacher.

With the military leave of Rick Dobbs, we hired an extraordinary mathematician to teach 7th grade math. Brian Kinkel is a 2009 graduate of the University of River Falls with certification to teach mathematics and physics. For all those with math phobia, this is a man who takes math classes for "fun".

The District is very fortunate to have hired West Salem resident and parent of three students as our school psychologist. Heidi Horton formerly was the head psychologist for the Onalaska School District. Heidi has a Master of Science in Education degree form UWL and Certificate of Advance Graduate Studies.

The administrative team recommended that we replace the former position of School Social Worker with a 70% position of elementary school counselor, due to the high number of elementary students

(822). Jennifer Grimsled earned a Master's degree in Guidance and Counseling from the University of Wisconsin Platteville and will enhance our counseling team.

Another extraordinary hire was Erin (Strutt) Ellerbach as a part-time elementary PE teacher. Erin is the daughter of former high school teachers Jackie and Dawson Strutt. Erin will also serve as middle school 8th grade volleyball assistant coach.

With the resignation of Kathy McHan, Laurie Klingemann was hired as a speech and language therapist with Terri Lenselink coordinating testing. Laurie will be working on her Master's Degree from the University of Wisconsin Steven's Point.

With 16 additional kindergarten students over our enrollment projections, it became apparent mid-August that a seventh section of kindergarten was needed to keep class sizes at 17 students. West Salem 2008 student teacher Carrie Zinn was hired to fill this new position. Carrie is a graduate of Vitterbo University and represented the US as a student ambassador to Great Britain and spent time volunteering in Mexico in soup kitchens and orphanages.

With the addition of the four-year-old kindergarten program, we hired two new instructors. Anna Squires is an experienced teacher from the Bering Straits School in Alaska. Anna has Master's Degree from Kaplan University and will teach two sections morning and afternoon, at the elementary school. Joining Anna is Barbara Wettstein who will be our morning Early Childhood teacher and afternoon integrated EC and 4K teacher. Barbara will soon obtain her Master's Degree from UW Steven's Point and has experiences teaching in the Holmen and Onalaska School Districts. Along with Barb and Anna, Megan McConkey, formerly 4th grade, and Kim Chaplain of Birchwood and Rachel Lysne of Little Learners join the 4K team.

With the addition of 4K bus routes, Carla Friet and Kathy Morgan were hired as bus drivers and both served the district as driver substitutes. Christen Bockenfeld and Marvin Iverson were hired as bus aides. Sandy Novak was hired as an elementary paraprofessional. Thus, our regular 2009-2010 school staff is almost complete.

We also welcome Annie Wachter-Labus as our Interim Community Fitness Center Director for Brad Frahm who is serving with the National Guard in Iraq. With her background directing fitness services at Fort McCoy we are fortunate to have Annie overseeing our center. Annie is happy to help you regarding your physical fitness routines.

Thank you for welcoming these staff members to our school and community.

According to library assistant Mrs. Olson, there are approximately 350 books checked out by students each day at the elementary.

The WSMS library assistant Renee Bradley, reported that almost 600 books have been check out in the first 8 days of school.

According to the high school's new librarian, Nicole Ellefson, "In the 8 days that we have had school this year we have had 659 students come into the library on a pass. This is an average of 82 students per day. On top of that, we have had 92 whole classes visit the library in those 8 days for research and computer use. That is an average of 11.5 classes in the library each day. Often there are two or three classes signed up for the library at one time."

State Testing

The start of school brings the anticipation of the Wisconsin Knowledge and Concepts Examinations. The testing window for the 2009-2010 school year is October 26 - November 27. This is a state-mandated test for all students in grades 3, 4, 5, 6, 7, 8, and 10. There are five components to the 4-8-10 grade test: Reading, Language Arts, Math, Science, and Social Studies. Grades 3-5-6-7 will test Reading and Math.

These tests are only one indication of how our schools are performing. There are many factors involved in school performance and the West Salem School District is dedicated and committed to providing quality education for our students and community. Please contact any of the school counselors if you have questions regarding WKCE testing: Gayle Lassen and Jennifer Grimslid at the elementary school, Mike Lang at the middle school, and Lynne Brown and Cathy Tyink at the high shool.

Attendance on testing days is extremely critical. If your child misses school, he or she will be required to make up the test at another time, and thus miss more school/class time. Please discuss the importance of these tests with your child(ren).

Following are some tips to help students be even more successful:

Make a commitment to do your best! * Get a good night's sleep prior to the test * Set the alarm to ring a little early to avoid having to rush in the morning * Pick out clothing at night before going to bed to avoid wasting time before going to school * Eat a good breakfast and lunch, but don't overeat * Wear comfortable clothingsomething you feel confident wearing * Try to clear your mind of all worries * Resolve any disagreements with family and friends * Avoid activities that may tend to create controversy or unpleasantness * THINK POSI-TIVELY ABOUT THE TEST! A POSITIVE ATTITUDE COUNTS AS DOUBLE * Recognize and accept anxious feelings * Do not become discouraged because of difficult test items * Listen and watch carefully while instructions are being given * If you don't understand the directions, ask questions IMMEDIATELY * Read directions guickly, but carefully * Work swiftly and accurately * Find the proper answer space on the answer sheet and mark it carefully * Make sure the answer sheet number is the same as the number of the test question * Complete all the easier items. Don't waste time on the difficult ones. Come back to them * Eliminate answers which you know are wrong, then check the remaining responses for key words * Narrow your choices down to two answers, but if you still can't decide make an educated guess * If you complete your test with time left, be sure to go back and check your work * Be sure to erase any dots or stray marks on your answer sheet * Read the questions first * Read all of the answers * Use your head * Pace yourself * RELAX * Give yourself positive and reassuring messages * Have confidence!

WINTER SPORTS PARENT MEETING

The winter pre-season sports meeting will be held on Monday, November 2, 2009 in the Heider Auditorium beginning at 7:00 p.m. This meeting is for those athletes interested in participating in boys' or girls' basketball, wrestling, gymnastics, hockey, skiing, winter cheerleading and winter poms, and their parents/guardians. The 7:00 - 8:00 general session is only for those parents and athletes who did not fulfill this obligation at the fall pre-season meeting. At 8:00 p.m. all athletes and parents are expected to attend the break-out session with the coach(es) of their respective sport. From 6:30 - 9:00, there will be stations set up in the lobby to check the necessary paperwork requirements of each athlete. All paperwork must be completed before beginning practice. Grade Advancement Policy - 345.4

The philosophy of the West Salem School District is for all students to achieve optimal learning based on high expectations and considerations of their abilities and needs. This applies to grade advancement of 4th to 5th and 8th to 9th grades and Wisconsin Knowledge and Concepts Exam (WKCE) results. The Board recognizes that students have diverse capabilities and interests and individual patterns of growth and learning. Therefore, the Board believes it is important that teachers have as much accurate knowledge of each student as is possible through daily observations and student records.

Because the promotion of students from the fourth grade to the fifth grade and from the eighth to the ninth grade is affected by State Statues (ss.118.33)(6)(a), this grade advancement policy applies to such promotions. Other district policies relating to the promotion of students apply if they are not inconsistent with this policy. Beginning on September 1, 2002, no student may be promoted from the fourth grade to the fifth grade or from the eighth grade to the ninth grade unless the student satisfies the criteria for promotion in this policy.

Grade advancement decisions will be based on the three criteria listed below. For those students opted-out of the WKCE, judgment is based on the other specified criteria.

A-1. Student Score on Wisconsin Knowledge and Concepts Exam (WKCE)

Receives a score of basic or above on 3 or more of the 5 subtests that compromise the WKCE.

AND

A-2. By achieving a grade point average of 2.0 or above (on a 12 point scale) in graded subjects; or

By successfully completing the Goals and Objectives on the Individual Education Plan (IEP).

OR

B. Teacher Recommendations

The recommendation will be determined through consensus of the Grade Advancement Committee. The Grade Advancement Committee from the elementary and middle school shall consist of the following membership: building principal or assistant building principal, guidance counselor, classroom teachers of the student in question, Director of Pupil Services or designee. In addition, the building principal may include others in the formal teacher recommendation, if deemed appropriate. The Grade Advancement Committee, in its formal process, may evaluate the following:

- The student's school development history.
- Student achievement level and curricular expectations.
- Alternative instructional strategies available and currently being implemented (remedial services, peer tutoring, etc.).

- 4. The extent of alternative programming available in both the new and repeated grade.
- 5. Age of the student.
- 6. The results of special education testing.

Parent (s) or guardian (s) will be invited to attend the meeting of the Grade Advancement Committee. However, the final decision rests with the West Salem Board of Education. The student may participate as deemed appropriate by parent (s) or guardian (s).

OR

C. Other Academic Criteria Specified by the School Board

Successful completion of an individual remediation plan designed by the Grade Advancement Committee.

The district administrator shall be responsible for the general supervision and management of the promotion of students under this policy. The district administrator or, if assigned the responsibility by the district administrator, the building principal shall determine whether a student has satisfied the criteria in this policy. This policy is designed to encourage early identification and interventions for those students who have academic, behavioral, and/or emotional difficulties. Written confirmation will be sent to the parent (s) or guardian (s) regarding the final decision by June 15 of the just completed school year. Decisions will apply for the following year.
