Letter from Superintendent Ryan Rieber

A Time for Thanks!

What a difference a year makes! I am so proud of where we are as a school district and the opportunities that we have provided our students. Unlike last year, our students have been in our buildings and classrooms working with our outstanding staff, which is the way we want it to be. Our students participating in co-curricular activities have found some tremendous success, including conference championships, playoff success, and our boys' and girls' cross country teams qualifying for state. Although challenges are still present, we are thankful that our students, staff, families, and community have been able to experience a fall full of opportunities and experiences.

The annual budget development cycle concluded on Monday, October 25th when the school board approved the final 2021-2022 school budget and the 2022 tax levy. The school board adopted the final budget to include a tax levy of \$9,950,735 with a mill rate of \$9.15. You will notice that the mill rate is \$0.39 less than a year ago, but the tax levy is slightly higher. This is due to a more than 8% increase in property values this year.

The approval of this budget marks the end of a threeyear operating referendum that was passed in April of 2019. As you will see with the included April 2019 Referendum Scorecard, we have been able to meet the promises that the District made back in 2019. We have been able to increase our fund balance to levels that meet our Board policy. The District made a focused effort to bring wages and benefits up to be more competitive with other school districts in our area. We established protocols for the upkeep and maintenance of our bus fleet including purchasing a new bus. The District utilized funds to update and maintain our high school and elementary school, and we strategically set money aside in order to replace the high school roof. We did all of this while keeping a mill rate at or below \$9.55. The District is so appreciative of the help and support from our community and it is important to share with you how we have been good stewards of the gifts that the community has provided.




