Letter from Superintendent Troy Gunderson

We officially welcome Fall 2016 with an updated format to our district newsletter. I hope you enjoy the beautiful fall colors and our new look!

This issue of the district newsletter includes information about a school district referendum included on the ballot for November 8th. The referendum will consist of two questions. The first question will seek permission to borrow up to \$20 million for renovations and additions to the middle school and updates at the elementary school. The second question will seek permission to borrow up to \$5 million to address improvements to several campus facilities including the construction of a multi-purpose events facility. Please check out this information!

In addition to shorter days and cooler nights, October also brings the Annual District Meeting. This unique Wisconsin tradition is an annual public meeting of the electors of the school district with a series of agenda items connected to the operation of the school district. The meeting is scheduled for Monday October 17, 2016 in the Heider Meeting room in the school district office. The evening will begin with a budget hearing at 6:30 p.m. followed the Annual Meeting at 7:00 p.m.

As we look ahead to the upcoming November election, I am reminded of our responsibility as citizens. A lengthy ballot awaits each of us as we are allowed to cast votes for President, US Senator, US Representative, WI Senator, WI Assemblyman, and yes – a school district referendum. Please do your part – cast your vote!

I am also reminded of the role compromise plays when our government works as designed. Regardless of election results, those entrusted to represent us are expected to work together to "get things done." On this point I offer praise to your current school board members who worked long hours this past summer to reach agreement on the upcoming referendum. The board members shared their thoughts, listened to the thoughts of others, talked with community members, reviewed possible solutions, and reached consensus.

Good work by good people on the right work at the right time. Thank you!

District Survey

Following the defeat of the April 2015 school district referendum, the school board conducted a district wide survey to gather input regarding a number of topics including district facilities.

The survey results indicated support for renovations and additions to the current middle school along with improvements needed to address campus traffic congestion and crowding in our elementary school. The report also indicated support for renovation and repair of the swimming pool, transportation garage, and a number of outdoor athletic facilities. Finally, the report suggested voter preference for any plan that did not raise taxes.

The school board responded to the survey results and to other feedback by offering a referendum in April of 2016 to address the issues at the swimming pool and bus garage. The two referendum questions were approved by a 4 to 1 margin. The construction projects at these two facilities are now in progress.

Following several months of planning, debate and eventual compromise, the school board unanimously approved of a motion to host a referendum on November 8, 2016. The school board again followed the advice of district residents and offered a plan to renovate and expand the middle school, to address campus traffic safety, to address crowding at our elementary school, and to address issues with various athletic facilities. Most notably, the school board offered a plan that will not raise taxes. By prepaying and refinancing long-term debt, the district is now in position to finance the proposed projects without increasing taxes.

District Finances and Taxes

Since the successful referendum in 2001 to renovate and expand the high school, the school district has made an average annual debt payment, or mortgage payment, of \$1.9 million per year. Over the past two years, these annual payments included "pre-payment" or principal payments to lower the outstanding debt. In the summer of 2016, the school district completed a final "refinancing" of the remaining debt on the high school project to capture savings offered by historically low interest rates. The result of this preparation affords the district the option of now financing \$25 million in new debt with approximately the same annual payment and therefore without raising taxes. In fact, district residents will experience a decline in the school tax rate for 2017 regardless of debt payment amounts due to increasing district property values and state-imposed revenue limits.

Boys and Girls Club

The West Salem chapter of the Boys' and Girls' Club serves approximately 150 students each day using both the middle school basement and rented space at a local church. The ultimate goal of the club and their donors is to create a permanent facility located on the school district campus – preferably in a school building.

The proposed construction project at the middle school includes renovations to the current basement, locker rooms, gymnasium, and entrance to literally build a "club" within our middle school. This is a win-win for the club, school district, taxpayers and students. The Boys' and Girls' Club has pledged a donation of \$2.5 million to the school district to cover both the cost of the proposed renovations necessary to create the club and to cover the proportional cost of infrastructure upgrades to the middle school facility. In addition, the Boys' and Girls' Club has agreed to share in the cost of utilities once the facility becomes operational.

To recap, the Boys' and Girls' Club will pay for the renovations necessary to create a club along with a share of the cost to upgrade the building infrastructure and a share of additional utility costs. The school district will be allowed to use the "club" during the day as the renovations will be designed as shared spaces for dual purpose use. The taxpayers get more "bang for the buck" as the additional funds allow for an improved renovation design. Most importantly, the students benefit from having access to a modern and safe Boys' and Girls' Club located right on our school campus allowing for connections with staff for improved after-school programming.

Senior Tax Exchange Program

The school district is considering the adoption of a program called STEP or Senior Tax Exchange Program. Simply put, the program allows senior citizens - those aged 55 and older who own property within the school district to volunteer at school in exchange for a reduction in property taxes. Similar programs are operating with great success at various school districts across our state and in other parts of the country. The key is allowing people to volunteer in areas of interest, expertise and comfort. This can be a fun way to serve our kids and lower your tax bill at the same time.

The West Salem School District School Board has approved the following school district referendum. The referendum will consist of two questions. The first will include renovations and additions to the middle school and updates to the elementary school.

Referendum Question 1 \$20,000,000

Approval of Question #1 would allow the school district to complete the following:

Middle School

- Two-story addition, including four individual grade level pods; one for each grade, 5-8.
 Each pod would contain classrooms and a center gathering space for lockers.
- Single-story space containing a cafeteria/ commons area, kitchen, music/choir area, secure entry connected to the office, and a twostation gymnasium.
- The funds provided by the Boys' and Girls' Club will be used to create a "new" club within the building by renovating

the current middle school basement, locker rooms, gymnasium, and east entry.

 Renovations and system modifications would include: heating, air conditioning, ventilation, fire alarm, electrical service, ADA compliance, roofing, doors and windows.

Elementary School

- A dedicated bus transfer area
- Additional parking
- Improved cafeteria serving area
- An events entrance
- Building infrastructure







The West Salem School District School Board has approved the following school district referendum. The referendum will consist of two questions. The second will address improvements to several campus facilities including the construction of a multi-purpose events facility.

Referendum Question 2 \$5,000,000

Approval of Question #2 would allow the school district to complete the following:

Improvements to Campus Facilities

- Renovation of the running track
- Construction of additional seating in the football/track stadium
- Construction of threediamond softball complex and renovation of the current varsity softball diamond into a junior varsity baseball diamond
- Construction of a new eightcourt tennis facility
- Completion of the related site improvements to include a parking lot and access road

Construction of a Multi-Purpose Events Facility

• The propsed multi-purpose events facility is a large open space facility that will serve as the center of a sports complex located near the current soccer fields. The building will accomodate a number of school related activities including:

- Ice hockey
 Indoor practice for soccer, softball, baseball, track, and tennis
- The restroom, concession, and changing areas will be designed to service the surrounding outdoor events, including soccer games, softball games, tennis matches, and cross country meets.
- This facility is also expected to function as a community events center with the ability to host a wide range of activities and events.
