Mrs. Griffin moved, Mrs. Kopnisky-Bloomfield seconded to accept donations from Harold and Barb Hoffman for the high school trap team, and from the Knights of Columbus for the special education program. Motion carried unanimously.

Mr. Schlimgen moved, Mrs. Kopnisky-Bloomfield seconded to adopt the following resolution: Resolution: Be It Resolved that the School District of West Salem will borrow on a short-term basis the sum of \$3,000,000 for the operation of the schools of the district: \$1,500,000 on October 26, 2018, with an additional \$1,500,000 on November 29, 2018, with a payment of \$1,500,000 to be made on December 14, 2018, and the final payment of \$1,500,000 on January 25, 2019. Motion carried unanimously.

Mr. Schlimgen moved, Mrs. Bloomfield seconded to approve the 2018-19 budget as presented and to set the 2018-10 school tax levy at \$8,188,099 with a Mill Rate of 0.00889. Motion carried unanimously.

Mr. Grosskopf moved, Mrs. Fitzgerald seconded to approve the 18-19 second semester Early College Credit Requests as presented. Motion carried unanimously.

Mr. Schlimgen moved, Mrs. Fitzgerald seconded to select Catherine Griffin to serve on the Boys' and Girls' Club Brenengen Board. Motion carried unanimously.

Mr. Schlimgen moved, Mr. Grosskopf seconded to select Syl Clements, Melinda Kopnisky-Bloomfield, Jane Halverson, and Robin Fitzgerald to review the Board Grant applications. Motion carried unanimously.

Mr. Clements welcomed the motion for closed session: The Board will discuss, consider and, if appropriate, take action in closed session pursuant to Wis. Stats §19.85(1)(f) "Considering financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations, regarding a professional staff member, and the discipline of a student.
