The meeting was called to order at 7:00 p.m. by President Thomas Helgeson. Approval of Agenda

Board Grant Review Committee – Mrs. Halverson reported that the committee met tonight and reviewed the three grants that were received and will make a recommendation later in the agenda.

Presentation by Lead Teachers Heidi Schiefelbein, Carrie Johnson, Teri Lassig, and Justin Jehn on how the services they provide are affecting students and staff.

Consent Agenda

Mr. Schlimgen moved, Mrs. Halverson seconded to approve the Regular Board Meeting Minutes of October 12, 2015; invoices to be paid; Open Enrollment Requests for the 2015-16 school year as presented; and Youth Options requests for the second semester as presented. Motion carried. (6-Aye, Mr. Helgeson abstained)

Discussion/Action Items:

Mrs. Halverson moved, Mrs. Griffin seconded to accept the donation from the family of George Rogers for the elementary school LMC. Motion carried unanimously.

Sue Peterson from School Perceptions reviewed the results of the survey taken by the residents and staff of the district. It was noted that there were 1026 respondents, a 25% response rate.

Mr. Schlimgen moved, Mrs. Griffin seconded to approve the following Resolution: Be It Resolved that the School District of West Salem will borrow on a short-term basis the sum of \$2,000,000 for the operation of the schools of the district: \$1,300,000 on October 28, 2015, with an additional \$700,000 on November 25, 2015, with a payment of \$1,000,000 to be made on

December 8, 2015, and the final payment of \$1,000,000 on January 20, 2016. Motion carried unanimously.

Mrs. Halverson moved, Mr. Clements seconded to approve the 2015-16 budget as presented. Motion carried unanimously.

Mrs. Halverson moved, Mr. Scafe seconded to approve to set the 2015-16 school tax levy at \$8,102,109. This includes \$524,000 in defeasance put towards paying down the debt on the high school project and will result in a mill rate of \$10.20. Motion carried unanimously.

Mrs. Griffin moved, Mr. Clements seconded to set the December Regular Board Meeting date as Monday, December 14, 2015. Motion carried unanimously.

Mr. Scafe moved, Mrs. Halverson seconded to approve the board grants, totaling \$4,670, as presented. Motion carried unanimously.

Mrs. Halverson moved, Mr. Clements seconded to approve for a first reading of policy #370-Rule B High School Co-Curricular Activity Eligibility Requirements and Code of Conduct, #830.3 District Fitness Center/Indoor Track and #321 School Calendar/Year. Motion carried unanimously.

Mrs. Halverson moved, Mrs. Griffin seconded to eliminate policy #341.3 Driver Education Policy. Motion carried unanimously.

Mrs. Griffin moved, Mr. Scafe seconded to hire Melanie Stellner as the production center administrative assistant. Motion carried unanimously.

Mrs. Halverson moved, Mr. Scafe seconded to accept the administration's middle school co-curricular recommendations: Justin Running-8th grade boys basketball and 7th grade girls basketball; Heather Jehn-7th grade boys basketball and 8th grade girls basketball; Amanda Beld-7th grade boys basketball assistant and 8th grade girls basketball assistant; track-Nicole Friell, Scott Johnson, Bill Jensen, and Sarah Weber; Stacy Rel-8th grade softball; Casi Rochester-7th grade softball; Tyler Shrake-wrestling; Morgan Bertzyk and Turner Albrecht-wrestling assistant; and Bill Jensen-8th grade boys basketball assistant. Motion carried unanimously.

Mrs. Halverson moved, Mr. Clements seconded to accept the retirement of Dave Rogers, Maintenance, and Jan Love, custodian. Motion carried unanimously.
