PROCEDURES AND REGISTRATION INFORMATION

The West Salem School District's summer school program will be held July 19 – August 6, 2021 from 8:00-11:30 a.m., and is available to all public and parochial school students who reside within the school district.

Students in grades K – 4 (incoming) will participate in a variety of learning activities to reinforce concepts and skills for the upcoming school year. Movement, music, art, and hands on practice will keep students engaged in learning. Those students who received math or reading support during the school year will be able to receive additional math and/or reading support during this time. K-4 summer school will be held at the elementary school.

- 11:45 Buses Dismissed

Busing Information

Buses will be assigned to limited designated areas/stops for summer school. Buses will **unload** students in the **front loop** at the elementary school and buses will **load** in the **bus loading zone** at the elementary school. Buses will be dismissed at 11:45. Please contact Monica Quinn at the District Office at 786-0700 to sign up for bus transportation. *There is no busing during June and July swimming lessons.

Student Drop Off and Pick UP

Students may be dropped off and picked up at the elementary school in the south (kindergarten wing) or north (gym side) parking lots. Drivers need to be very alert to children exiting vehicles. Please drive slowly. The front loop at the elementary is for buses only until 8:30 a.m. or if buses are present.

Students may arrive no earlier than 8:00 a.m. and go to the following locations:

Grade K-1ES South PlaygroundGrades 2-4ES North Playground*On the first day, teachers will meet students outside on the playground. Teachers will show studentswhere classrooms are on the first day.

Students walking to and from school should stay on designated routes determined by parents and using crossing guard assistance when available. Students must go directly home or to their designated location right after summer school dismissal. Parents should talk to their children about the danger of accepting rides or going anywhere with strangers.

School Meals

Breakfast: Students may choose to have a free school breakfast or bring a breakfast from home. A free "grab and go" breakfast will be available for students to take his/her classroom upon entering the building for summer school.

Lunch: A free "grab and go" cold lunch will be available to students at summer school dismissal. Students will need to wait to eat until they reach their after school destination. Students will not be allowed to eat on the bus.
